## Waiver of Liability, Assumption of Risk and Indemnity Agreement For MBL Memphis' grind. Youth Basketball Camp

Waiver: In consideration of being permitted to participate in MBL Memphis' grind. **Indemnification and Hold Harmless:** I also agree to INDEMNIFY AND HOLD THE **MBL Memphis' grind. Youth Basketball Camp** HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorney's fees brought as a result of my involvement in the **MBL Memphis' grind. Youth Basketball Camp** and to reimburse the **MBL Memphis' grind. Youth Basketball Camp** for any such expenses incurred.

**Severability:** The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the laws of the state of Tennessee and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**Acknowledgement of Understanding:** I have read this waiver of liability, assumption of risk and indemnity agreement, fully understand its terms, have been given an opportunity to consult with counsel, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a release of liability to the greatest extent permitted by law.
